Dear Fish Transportation Permit Applicant,

Enclosed is your Fisheries Application for Permit to Transport Live Fish, Live Bait or other Aquatic Organisms. Your renewed permit will be effective for 12 months <u>from the date of issue</u>. Permit holders are responsible for renewing their permit prior to the current permit expiring.

If you intend to transport live fish into, within, or through Kentucky or if you intend to have your commercial fishing helper transport roe-bearing fish or roe in your absence, please complete and submit the enclosed Application for Fish Transportation Permit to the department along with the \$25 permit fee. Please note that Florida Bass and F1 Hybrids are not permitted into, within, or through Kentucky.

The Kentucky Department of Fish and Wildlife furnishes a list upon request of Commercial Propagation Permit and Transportation Permit holders, along with the species listed on the permit. This list is mainly requested by the public when seeking a fish supplier. If you would like to be on this list, please indicate below. Your name will be placed on the list alphabetical as indicated on your application. Be sure to include a phone number.
