INSTRUCTIONS ON BACK

How To Apply for a Shoreline Use Permit

The following information will assist you with the procedures to obtain a Shoreline Use Permit for structures on Department Property according to 301 KAR 1:016. This permit covers new and existing access structures at Beaver, Carpenter, Corinth, Elmer Davis, Guist Creek, Kincaid, and Malone lakes.

There is a fee that ranges from \$100 to \$300 for a 15-year permit period (1/1/2010 - 12/31/2024) that is based on the type of construction (tier). Department personnel will conduct an on-site visit to determine the amount you must pay. The fee is also pro-rated (on 5-year intervals) if you construct an access structure within the 15-year permit period. **Payment should not be sent until the Department notifies you of the fee.**

For An Existing Access Structure on Department Property

- 1. Submit to the Department a completed Shoreline Use Permit application.
- 2. If your access structure was constructed prior to April 15, 2010, it shall be grandfathered for the life of the structure. Unapproved structures constructed after that date will not be grandfathered and may result in legal action and removal of the structure.
- 3. After receiving your permit application, Department personnel will conduct an on-site visit to verify the type of structure present and the appropriate fee.
- 4. You will then receive your returned Shoreline Use Permit application with notification of your payment amount.
- **5.** Upon receiving payment, you will be mailed your Shoreline Use Permit.

If Constructing a New or Rebuilding an Existing Access Structure on Department Property

- 1. Submit to the Department a completed Shoreline Use Permit application and with detailed plans of the access structure(s) to be constructed or rebuilt. Proposed plans must follow specifications set forth in 301 KAR 1:016.
- 2. After receiving your permit application and proposed plan, Department personnel will conduct an on-site visit to inspect the existing structure(s) and/or discuss the design of a new or rebuilt access structure(s).
- 3. When plans are approved, you will again receive your Shoreline Use Permit application with notification of your payment amount.
- 4. After receiving the permit fee, the Department will provide you with written approval that you may begin construction.
- 5. Construction must follow specifications listed in 301 KAR 1:016 and must be completed within one (1) year from the date of construction approval provided on the letter.
- 6. After construction is completed, you must notify the Department.
- 7. Department personnel will then conduct a final on-site inspection of the newly constructed or rebuilt access structure(s).
- 8. If approved, you will be issued your Shoreline Use Permit.

If you are submitting a Shoreline Use Permit application for an existing access structure and want to rebuild or construct an additional structure, you may submit both on a single permit application.

If you would like to expedite the approval process, please include your email address on the Shoreline Use Permit application and any written contact and approval will be emailed to you. Failure to complete this permit process will result in a violation of 301 KAR 1:016 which may result in legal action.
