

# INDIVIDUAL TRANSPORTATION PERMIT APPLICATION

**Application fee: \$25.00 per shipment**

Prior to entry into Kentucky, a Transportation Permit must be obtained for each shipment of wildlife. **Application must be made by** persons who (1) receive a shipment of wildlife; (2) import wildlife for use or possession within Kentucky; or (3) transport wildlife into and through the state to a destination outside Kentucky.

It is understood that any permit issued is void and prosecution will ensue if the transaction involves any violation of the laws or regulations of Kentucky or the state from which the wildlife is imported. This permit is invalid unless accompanied by a Certificate of Veterinary Inspection from an accredited veterinarian indicating that the wildlife being transported under this permit are free of disease (except reptiles and amphibians). I further understand that I am responsible for knowing and following any and all local ordinances and rules related to the possession and holding of wildlife in any locality in which the wildlife listed above will be held or possessed. I will obtain any local permissions required.

Permittee agrees to indemnify and hold harmless the KDFWR from any and all claims, demands, damages, actions, costs and charges, including attorney's fees, that may result from use of this permit.

Correct payment must accompany application. Receipt and cashing of payment does not imply approval of permit request.

I certify that I have read and understand the above, 301 KAR 2:081 and/or 301 KAR 2:082, and that all information contained in this application is correct. I further certify that I have not been convicted of a fish and wildlife violation, including KRS Chapter 150, KAR Title 301 and federal wildlife laws.
