DEER HUNTING

2024-25 DEER HUNTING ZONES and SEASONS

DEER BAG LIMITS Only one antlered deer may be harvested statewide, regardless of zone or method.			
ZONE 1	A hunter may harvest an unlimited number of antlerless deer in Zone 1 using the statewide deer permit and additional deer permits.		
ZONE 2	A hunter may harvest no more than four deer in Zone 2.		
ZONE 3	A hunter may harvest no more than four deer in Zone 3. A firearm or air gun cannot be used to take more than one antlerless deer.		
ZONE 4	A hunter may harvest no more than two deer in Zone 4. Only one can be antlerless. Antlerless deer cannot be harvested during the modern gun season, the early muzzleloader season or the first six days of the late muzzleloader season. The statewid bag limit of one antlered deer still applies.		

GENERAL INFORMATION

- The statewide deer permit and youth deer permit allow for the harvest of up to four deer. Hunters may take up to one antlered deer and three antlerless deer, or four antlerless deer using the statewide deer permit.
- A hunter may take as many deer as allowed in each zone. In order to take more than four deer statewide, an additional deer permit must be purchased.
- Each additional deer permit allows a hunter to take up to two additional deer. Zone bag limits apply. Using an additional deer permit, a hunter who did not harvest an antlered deer using a statewide or youth deer permit can take either: one antlered deer and up to one antlerless deer; or two antlerless deer.
- Shooting hours are 30 minutes before sunrise to 30 minutes after sunset.
- Hunters must claim any deer they harvest as their
 own

BAG LIMITS

Bag limits and harvest restrictions apply to all hunters. There is no daily bag limit on deer. A person may take no more than one (1) deer with visible antlers, excluding male fawns (button bucks). However, on some federally controlled areas, including Reelfoot National Wildlife Refuge, Fort Campbell and Fort Knox military reservations and Blue Grass Army Depot, a bonus antlered deer may be taken, as determined by the governing agency for each area.

CHECKING and TAGGING

All deer must be telechecked. Hunters must call 1-800-245-4263 or complete the online check-in process at *fw.ky.gov*. See the "Recording, Checking, Tagging and Transporting" portion of this guide's "General Information" section for full details.

If the hide or head is removed before the harvested deer is checked in – to quarter the animal, for example – it is necessary to demonstrate proof of sex by retaining the head or keeping the genitalia attached to the carcass. In such cases, it is still necessary to fill out the harvest log immediately after harvest and telecheck the animal before midnight on the day the deer is harvested or recovered.

A carcass tag is required if a harvested deer leaves the hunter's possession for any reason.

STATEWIDE DEER PERMIT

All deer hunters ages 16 and older, unless license exempt, must first buy

Carry proof

Hunters who buy their license or permit by phone or internet must carry while hunting: a picture ID and proof of purchase (an authorization number, paper license or computer print out). Paper licenses/permits must be signed and all information completed before hunting.

and carry proof of purchasing an annual hunting license and a statewide deer permit while deer hunting. The permit allows a hunter to take four deer: one antlered and three antlerless, or four antlerless. It does not matter if the antlered or antlerless deer is taken first.

ADDITIONAL DEER PERMIT

To take more than four deer, an additional deer permit must be purchased. The additional deer permit is valid for deer of either sex. The additional deer permit allows a hunter to take up to two additional deer beyond those allowed by the statewide permit in the following combinations: one antlered and one antlerless, or two antlerless. Regardless of what permit a deer hunter carries, the statewide season limit for antlered deer is one per hunter. The additional deer permit is not valid unless the hunter has first purchased an annual hunting license and statewide deer permit and is able to show proof of that in the field. A statewide or additional deer permit may be used on public and private land, and during some quota hunts.

CHRONIC WASTING DISEASE

Chronic Wasting Disease (CWD) is fatal to white-tailed deer, elk and other members of the deer family. CWD was detected in Ballard County in December 2023.

STATEWIDE CARCASS IMPORTATION RESTRICTIONS

It is illegal to bring whole carcasses or parts containing brain material of any member of the deer family into Kentucky from outside the state. Hunters can only bring back the following: deboned meat, antlers, antlers attached to clean skull cap, clean skulls, clean teeth, hides and finished taxidermy products.

GET INVOLVED

Hunters can get their Kentuckyharvested deer tested for CWD during the season by:

- Dropping off deer heads at a CWD Sample Drop-off site (see page 14). Heads may be caped out or skull capped, but must include 5 inches of neck.
- Contacting a local biologist by calling 1-800-858-1549.
- Participating in the "DIY" CWD mail-in kit pilot program. Visit fw.ky.gov/CWD for more information.

HUNTING EQUIPMENT RESTRICTIONS

MODERN GUN SEASON

During modern gun deer season, hunters may hunt with any centerfire rifle or pistol, including air guns of .35 caliber or larger charged by an external tank, muzzleloaders, and archery and crossbow equipment, and must follow season restrictions, zone guidelines and other hunting requirements.

All hunters, including archery and crossbow hunters, and persons accompa-

nying hunters, must wear hunter orange clothing during modern gun season.

Persons ages 15 and younger hunting deer with a firearm must be accompanied by an adult who shall be in a position to take immediate control of the youth's firearm at all times.

ARCHERY SEASON

Hunters using archery equipment during a deer, elk or bear firearms sea-

Devices designed to entangle or trap the antlers of a deer cannot be used.

son must follow all firearms deer season restrictions, zone guidelines and other hunting requirements, and must wear hunter orange clothing. The only exception is on state-owned or managed WMAs where firearms hunting for deer or elk is prohibited.

CROSSBOW SEASON

Hunters using crossbows during a deer, elk or bear firearms season must

follow all firearms deer season restrictions, zone guidelines and other hunting requirements, and must wear hunter orange clothing. The only exception is on state-owned or managed WMAs where firearms hunting for deer or elk is prohibited. A legal resident hunter age 65 years or older and a youth hunter age 15 or younger may hunt deer with a cross-bow from the first Saturday in September through the third Monday in January.

MUZZLELOADER SEASON

Muzzleloaders, archery and crossbow equipment may be used during this season. All hunters must comply with the hunter orange clothing law. Youths ages 15 and younger hunting deer with a muzzleloader must be accompanied by an adult who shall remain able and in a position to take immediate control of the youth's muzzleloader at all times.

TREE STANDS

Construction and use of tree stands on private lands is regulated by landowners.

Hunter orange required!

Hunters and people accompanying them must wear solid, unbroken hunter orange color visible from all sides on the head, back and chest when hunting for any species during modern gun, muzzleloader and youth gun deer seasons, or a firearm elk or firearm bear season. However, hunter orange is not required when hunting waterfowl or doves during a gun deer, elk or bear season, or when hunting furbearers at night during a legal furbearer season.

SUBMIT IMAGES OF YOUR DEER'S JAW BONE FOR AGING

LEGAL DEER HUNTING EQUIPMENT

Scopes are allowed on all hunting equipment (used for statewide seasons).

MODERN GUN EQUIPMENT

- Any caliber centerfire rifle or centerfire handgun.
- Rifle, handgun or shotgun magazines may not be capable of holding more than 10 rounds.
- Rifles or handguns may not be fully automatic (capable of firing more than one round with one trigger pull).
- Full metal jacketed or tracer bullet ammunition is prohibited.
- Shotguns, no larger than 10-gauge, shooting slug ammunition only (includes saboted bullets).
- Muzzle-loading rifles, handguns, or shotguns shooting round balls, conical bullets, or saboted bullets.
- Air guns of .35 caliber or larger charged by an external tank, shooting single projectile ammunition designed to expand upon impact.

ARCHERY EQUIPMENT

 Longbows, recurves and compound bows of any draw weight (no minimum).

- Wood, carbon or metal arrows, but arrows may not be chemically treated.
- Fixed blade or mechanical broadheads at least 7/8" wide (when blades extended), but broadheads may not be chemically treated.

CROSSBOW EQUIPMENT

- Crossbows of any draw weight (no minimum), with a working safety.
- Wood, carbon or metal arrows (bolts), but arrows (bolts) may not be chemically treated.
- Fixed blade or mechanical broadheads at least 7/8" (when blades extended), but broadheads may not be chemically treated.

MUZZLELOADING EQUIPMENT

- Muzzle-loading rifles or handguns of any caliber, shooting round balls, conical bullets or saboted bullets.
- Muzzle-loading firearms equipped with open sights or telescopic sights (scopes).
- Muzzle-loading shotguns no larger than 10-gauge, shooting round balls, conical bullets or saboted bullets.

YOUTH DEER HUNTING

YOUTH DEER HUNTING

Youths may hunt deer during any open season, including two special deer seasons for resident and nonresident hunters who have not reached their 16th birthday.

Adults accompanying youth deer hunters during either of these hunts may not use firearms to take deer.

Adults accompanying youth hunters are not required to possess a hunting license or deer permit if the adult is not deer hunting, but by law, the hunter and the accompanying adults must wear hunter orange clothing.

YOUTH-ONLY GUN SEASON/ FREE YOUTH DEER HUNTING WEEKEND

The first special youth deer season is on the second weekend of October. Youth hunters may take deer with fire-

arms, or any other legal method, statewide. During the October youth-only firearms season, the appropriate hunting license and deer permits are required for hunters ages 12-15. Youth hunters younger than age 12 are not required to have a hunting license or deer permit. On the first weekend following Christmas, resident and nonresident youth 15 years of age and younger, who are accompanied by an adult, are eligible to participate in the free youth weekend. Youth hunters may hunt deer with firearms, or any other legal method, statewide without a hunting license or deer permit. During these seasons, youth hunters may harvest antlered or antlerless deer regardless of zone but must still abide by all bag limits and other deer hunting requirements.

SPECIAL DEER REGULATIONS

affecting Ballard, Breckinridge, Calloway, Carlisle, Fulton, Graves, Hardin, Hickman, Marshall McCracken and Meade counties

Kentucky has established two surveillance zones to monitor for the presence of Chronic Wasting Disease, or CWD. These are located in western Kentucky and northcentral Kentucky. Special regulations apply to both zones. CWD is fatal to white-tailed deer, elk and other members of the deer family. **ZONE** Surveillance zones were es-**WITHOUT** tablished in an effort to **MANDATORY** limit the spread of this Hardin CHECK disease. **STATIONS ZONE WITH MANDATORY CHECK STATIONS**

CWD SURVEILLANCE ZONE WITH MANDATORY CHECK STATIONS

- Ballard, Carlisle, Calloway, Fulton, Graves, Hickman, Marshall and Mc-Cracken counties.
- All deer harvested within this CWD Surveillance Zone on Nov 9-11, Nov 16-17 and Nov 23-24 (all weekends of modern gun season) must be brought to a CWD check station or submitted for sampling. Testing is free.
- No deer baiting allowed.
- No change to deer seasons or bag limits.
- · Only hides, deboned meat or antlered

- skull caps without tissue may be taken outside of the zone.
- Kentucky Fish and Wildlife will notify participants if samples test positive for CWD.

CWD SURVEILLANCE ZONE WITHOUT MANDATORY CHECK STATIONS

- Breckinridge, Hardin and Meade counties.
- Deer harvested within this CWD Surveillance Zone do not have to be brought to a check station. Hunters

- are encouraged to submit samples for free testing.
- Visit a CWD Sample Drop-off site (see page 14 for list) to submit a sample any time deer season is open.
- Kentucky Fish and Wildlife will notify participants if a submitted sample tests positive for CWD.
- No deer baiting allowed.
- No changes to deer seasons or bag limits.
- Only hides, deboned meat or antlered skull caps without tissue may be taken outside of the zone.

CWD CHECK STATION INFORMATION

MANDATORY CWD CHECK STATIONS

All deer harvested within the CWD Surveillance Zone With Mandatory Check Stations (Ballard, Carlisle, Calloway, Fulton, Graves, Hickman, Marshall and McCracken counties) on Nov 9-11, Nov 16-17 and Nov 23-24 (all weekends of modern gun season) must be submitted for testing. Hunters may take their deer to a staffed check station or leave a head or sample at a Sample Drop-off Site.

This requirement applies to all hunters harvesting deer within the CWD Surveillance Zone With Mandatory Check Stations by any method. This includes landowners hunting on their own property, youth hunters or any license-exempt hunter. Sampling is required during these dates even if a deer is given to others by a hunter. All deer must be telechecked before coming to a check station or sample site.

Kentucky Fish and Wildlife also provides freezers for sample drop-off

at multiple locations throughout the state. Hunters who take a deer within a Surveillance Zone must use freezers within the zones. Hunters who harvest deer outside of the surveillance zones may drop off a deer head at any CWD Sample Drop-off Site. Instructions for leaving samples are included at each site. Freezers are available day or night, every day of the week. Testing for CWD is free.

CHOOSE YOUR PREFERRED MANDATORY CHECK STATION

VISITING A STAFFED CWD CHECK STATION

CWD Check Stations in western Kentucky will be staffed from 9 a.m. – 7 p.m. (Central) on Nov. 9-11, Nov. 16-17 and Nov. 23-24.

- What do you bring? The head of the deer, an intact deer carcass or a field-dressed deer.
- What do you need to provide?
 Telecheck and licensing information, an approximate harvest location and the name of taxidermist or processor (if applicable).

VISITING A CWD SAMPLE DROP-OFF SITE

See list at right for locations. CWD Sample Drop-off sites are self-service only.

- What can you drop off? The head with at least 5 inches of neck attached. Remove antlers from bucks. Heads that have been caped and skull capped may be submitted. Instructions, bags and tags are located at each site. Deer parts dropped at freezers are not returned; visit a staffed check station instead if you wish to keep them.
- What do you need to provide? Telecheck and licensing information, approximate harvest location and hunter contact information.
- What should you keep? Retain the tear-off portion of your freezer tag for proof that you checked the deer.



DEER BAITING and WILDLIFE FEEDING

Applies to all CWD Surveillance Zone counties

➤ Prohibited: Grain, feed, mineral blocks, salt blocks and other baits for deer. ✓ Allowed: Bird feeders in yards, planted food plots, normal agricultural practices such as mineral blocks or feed for cattle, scent attractors and deer urine products.

CARCASS TRANSPORTATION RESTRICTIONS

What may be taken outside of the CWD Surveillance Zone

➤ **Prohibited:** Whole carcasses, highrisk parts including head, intact skull or

skull cap with brain material, or spine.

✓ **Allowed:** Deboned meat, antlers, antlers attached to clean skull cap, clean skulls, clean teeth, hides and finished taxidermy products.

✓ Allowed: Carcasses of Kentucky deer harvested outside of a CWD Surveillance Zone may be brought into a CWD Surveillance Zone. Deer carcasses from outside of the state cannot be brought into Kentucky.

STATEWIDE CARCASS IMPORTATION RESTRICTIONS

It is illegal to bring whole carcasses or high-risk parts (head, intact skull or skull cap with any brain material, or spine) of any member of the deer family (deer, elk, moose, or caribou, etc.) into Kentucky from other U.S. states or Canadian provinces.

DOES CWD INFECT PEOPLE?

The Centers for Disease Control and Prevention (CDC) states there is no evidence to suggest that CWD can infect people. To date, there have been no reported cases of CWD infection in humans. Out of an abundance of caution, the CDC recommends that people do not consume meat from an animal that appears sick or has tested positive for CWD.








HOW TO GET ON NEXT YEAR'S TOP DEER LIST

To be eligible for next year's list a hunter must take a white-tailed deer in Kentucky this season that officially net scores 160 or higher typical, or net scores 185 or higher non-typical, as determined by the Boone and Crockett scoring system. Velvet deer scored under Pope and Young Club system must meet these minimums for list inclusion.

No later than May 1, send the completed and signed score sheet with a photo to Kentucky Hunting & Trapping Guide, #1 Sportsman's Lane, Frankfort, KY 40601. Include the county in which the deer was taken, and the equipment used to harvest the deer. Please send a copy as score sheets and photos will not be returned.
