INITIAL THE FOLLOWING STATEMENTS:

_____ I understand that any permit issued is void if the transaction involves any violation of federal or state wildlife laws or regulations.

_____ I understand that this permit is invalid unless accompanied by a Certificate of Veterinary Inspection from an accredited veterinarian indicating that the wildlife being transported under this permit are free of disease (except reptiles and amphibians).

_ I understand that all game birds must originate from a National Poultry Improvement Program (NPIP) certified flock. The NPIP flock number or both the test date and laboratory of the test shall be recorded on the Certificate of Veterinary Inspection.

Pursuant to 301 KAR 2:081 and 2:082, I understand that I must notify the Kentucky Department of Fish and Wildlife Resources of any amendments to the original application at least forty-eight (48) hours prior to any wildlife shipment by calling the department telephone number at 800-858-1549, Monday through Friday between 8:00 am and 4:30 pm or email FWPermits@ky.gov.

_ I, the undersigned, shall indemnify and hold harmless KDFWR and all of its officers, agents, and employees from all suits, actions, or claims of any character because of any injuries or damages received by any person, persons, or property resulting from the use of this permit, to the extent allowed by Kentucky law. No part of this agreement shall constitute, either directly or indirectly, a waiver of sovereign immunity granted under the Kentucky Constitution, Section 231, and the United States Constitution, Eleventh Amendment.

_____ I understand that receipt and cashing of payment does not imply approval of permit request. Correct payment must accompany application.

_____ I certify and understand that my permit shall be revoked and/or denied and wildlife confiscated if I fail to comply with the provisions of this administrative regulation, 301 KAR 2:041, 301 KAR 2:082, 301 KAR 2:084, 301 KAR 2:195, 301 KAR 2:230, or 301 KAR 2:251, if I am convicted of a violation of KRS Chapter 150, any department regulation, or any federal statute or regulation related to hunting, fishing, or wildlife or if I falsify information on this application, reports, or corresponding documents.

_____ I certify that I have not been convicted for a violation of KRS Chapter 150, 301 KAR 2:081 and/or 301 KAR 2:082, the administrative regulations promulgated under its authority, or hunting, fishing, or wildlife laws of the federal government, within the denial period established in 301 KAR 2:081.

_____ I understand that I am responsible for following all federal and state laws, local ordinances, and rules regarding wildlife.

_____ I understand that I must also have a valid captive wildlife permit to possess native species **BEFORE** transporting them into KY. Exceptions for reptiles/amphibians: up to 5 individuals of each species of reptile and amphibian may be possessed for personal use without a captive wildlife permit. Exceptions for northern bobwhite quail: Up to 100 northern bobwhite quail may be possessed for personal use without a captive wildlife permit, provided they are not propagated or sold, legally obtained, and confining facilities meet the enclosure requirements in 301 KAR 2:081. Exceptions for temporary possession: Wildlife imported into KY for less than 10 days held in a temporary facility may be possessed without a captive wildlife permit. Moving to KY: A person in legal possession of wildlife that moves to Kentucky has 30 days to pass a facility inspection and apply for a captive wildlife permit.
