

INDIVIDUAL TRANSPORTATION PERMIT APPLICATION

Application fee: \$25.00 per shipment

Prior to entry into Kentucky, a Transportation Permit must be obtained for each shipment of wildlife. **Application must be made by** persons who receive a shipment of wildlife; import wildlife into Kentucky; or transport wildlife into and through the state to a destination outside Kentucky.

It is understood that any permit issued is void if the transaction involves any violation of the laws or regulations of Kentucky. This permit is invalid unless accompanied by a Certificate of Veterinary Inspection from an accredited veterinarian indicating that the wildlife being transported under this permit are free of disease (except reptiles and amphibians). I further understand that I am responsible for following local ordinances and rules regarding the wildlife to be held in a locality. I will obtain any local permissions required.

Applicant(s) shall indemnify and hold harmless KDFWR and all of its officers, agents, and employees from all suits, actions or claims of any character because of any injuries or damages received by any person, persons, or property resulting from the use of this permit, to the extent allowed by Kentucky law. No part of this agreement shall constitute, either directly or indirectly, a waiver of sovereign immunity granted under the Kentucky Constitution, Section 231, and the United States Constitution, Eleventh Amendment.

Correct payment must accompany application. Receipt and cashing of payment does not imply approval of permit request.

I certify that I have read and understand the above, 301 KAR 2:081 and/or 301 KAR 2:082, and that all information contained in this application is correct. I further certify that within the last year I have not been convicted of a violation of 301 KAR 2:081 and/or 301 KAR 2:082, or another federal or state wildlife law regarding the holding or transportation of wildlife.
