

# Fishing Line Recovery and Recycling Program

## Volunteer Agreement

This document will outline the responsibilities assumed when committing to monitor and maintain a fishing line outdoor collection bin as part of the Kentucky Department of Fish and Wildlife Resources' Fishing Line Recovery and Recycling (FLRRP) program.

The individual or group volunteer(s) agrees to:

1. Check the collection bin on a regular basis for general appearance, stability, and contents (frequency dependent on site conditions). Report any issues or concerns to KDFWR.
2. Empty the bin as necessary and prior to being completely full.
3. Properly dispose of all trash.
4. Remove all hooks, leaders, weights, lures or other fishing paraphernalia from the monofilament.
5. Properly dispose of any braided or fluorocarbon line or monofilament encrusted with vegetation or bait that cannot be reasonably cleaned.
6. Deposit all cleaned and cleared monofilament in a Berkley indoor recycling station.\*
7. Record the amount of line recovered during each visit on the FLRRP data sheet. Completed forms can be mailed, faxed, or emailed to KDFWR.
8. Notify KDFWR if you wish to terminate the commitment so that a new volunteer can be found.

\*You may request monofilament return boxes to keep at your home or you can drop off at a specified location. Check the map or contact [fw.fisheries@ky.gov](mailto:fw.fisheries@ky.gov) to find the closest drop off location.
